The 2004-2005 SCYYRA Shadden Series Regatta #2 for CFJ class boats will be hosted by California Yacht Club (CYC) on Sunday, October 10, 2004. CYC is located at 4469 Admiralty Way, Marina del Rey, CA 90292, phone 310.823.4567. Information about CYC and this regatta is available at www.calyachtclub.com.

Rules. This regatta will be governed by the "**rules**" as defined in the 2001-2004 Racing Rules of Sailing (RRS). RRS 40 will be changed to apply regardless of whether code flag "Y" is displayed. SCYYRA Shadden Series Standing Rules will apply. CFJ Class Rules 34 (Boat Weight) and 35 (Crew Weight) will apply.

Eligibility. This regatta is open to CFJ class boats. Each participant shall be under 21 years of age during the series and must be a member of an SCYA or SCYYRA yacht club. Either the skipper or crew must be a member in good standing of the CFJ Class.

Entries. Each entrant must submit a completed CYC Entry Form to the Race Committee before the start of the Skippers' Meeting at 0930 hours on Sunday, October 10. **Competitors under eighteen years of age must have their Entry Form signed by a parent or guardian.** Late entries will be accepted only with the prior approval of the Regatta Chairman. There is no entry fee.

Racing / Courses. The racing area will be on Santa Monica Bay approximately one (1) nautical mile northwest of the entrance to Marina del Rey. The Race Committee will attempt to conduct five (5) races but may run fewer races at its discretion. Courses will be primarily windward / leeward with some reaching legs if conditions warrant.

Sailing Instructions. The Sailing Instructions will be available at the CYC front desk beginning Sunday, October 3 and may also be posted at www.calyachtclub.com.

Tows. Courtesy tows to the racing area will be available in the vicinity of the launch area; however, it is the responsibility of each competitor to be at the start on time.

Scoring. The Low Point Scoring System of RRS Appendix A2 will apply except that all races will count (*i.e.*, there will be no discard). Two (2) races must be completed to constitute a regatta.

Hospitality. Box lunches will be available for purchase from the CYC Snack Bar. Competitors and their guests are invited to use club facilities on race day. Refreshments will be provided following the last race.

Prizes. Prizes will be awarded after racing.

RACE ENTRY AGREEMENT - Please Read Carefully 10/23/98

In consideration of acceptance of my entry by California Yacht Club ("CYC"), I acknowledge and agree as follows:

1. I own or have chartered the boat entered and I am a member of a yacht club or sailing association that belongs to USSA. My boat will be equipped to conform with USCG, USSA and Class/Fleet safety requirements.

2. I am personally responsible for the operation of my boat and will comply with the rules of the ISAF as adopted by the USSA, and with all laws, rules and sailing instructions governing the race and use of the marina, including Cal. Harbors & Navigation Code.

3. CYC is not my insurer. I will maintain sufficient insurance to protect from all risks arising from this Agreement.

4. **ASSUMPTION OF RISK.** THERE ARE RISKS INHERENT IN THE SPORT OF YACHT RACING, AND I FREELY ASSUME ALL RISKS, INCLUDING PERSONAL INJURY OR DEATH TO MYSELF AND MY CREW, LOSS OR DAMAGE TO MY YACHT AND ITS

EQUIPMENT, AS WELL AS UNFORESEEN RISKS.

5. **WAIVER, RELEASE AND INDEMNIFICATION.** TO THE FULLEST EXTENT PERMITTED BY LAW, I WAIVE ALL CLAIMS, FOREVER RELEASE AND AGREE TO INDEMNIFY AND HOLD HARMLESS CYC, IT'S OWNERS, AFFILIATES, OFFICERS, EMPLOYEES, AGENTS, COMMITTEE PERSONS AND RACE OFFICIALS ACTING IN THEIR OFFICIAL CAPACITIES, FROM ANY DAMAGE, LIABILITY, LOSS, COST OR EXPENSE INCLUDING ATTORNEY FEES, ARISING FROM MY AND MY CREW'S PARTICIPATION IN THE RACE, INCLUDING CYC'S ACTIVE OR PASSIVE REGULAR NEGLIGENCE, BUT NOT CYC'S WILLFUL MISCONDUCT OR GROSS NEGLIGENCE.
