3. **Fees**

Entry fees in the amount of \$30.00 shall be made payable to San Diego Yacht Club for the regatta. If you are not already registered for the 2005-2006 Perry Series an additional \$30.00 entry fee payable to SCYYRA and a separate Perry Series registration form should be completed.

4. **Scoring**

The Low Point System of the RRS Appendix A will apply. Nine races will be attempted. There will be one throw-out if four (4) or more races are completed. This modifies RRS A2. The Perry Series scoring shall be based on the official results of each regatta tabulated against other Perry Series entrants.

5. **Eligibility and Boats**

Participants shall be members of the Club 420 Class Association and Class legal Club 420s must be sailed.

6. **Sailing Area**

Approximately one mile southeast of Zuniga Jetty

7. **Sailing Instructions**

Sailing instructions will be available at registration.

8. **Prizes**

Trophies will be awarded to the top three teams.

9. **Extras**

SDYC Junior Sailing will host hot dogs and burgers on Saturday after sailing.
