## Guide for Host Clubs



### Pre-Regatta (Friday before)

#### RC Supplies

RC Signal Boat

RC Finish Boat

Mark Set Boat (can also be a coach boat)

Marks (4 for course, 1 for start, 1 for finish)

Flags (2 red/orange for start and finish boats, X, 1<sup>st</sup> repeater, postponement)

White board to display race number, and results of any protests

Sound signaler and back up

#### Forms

Individual Race Score Sheets, print enough to cover all races

Sailing Instructions

#### Boat designations

Check with Caleb for bibs prior to the day of the regatta.

### Regatta Start

#### Registration

Have entry list ready

Have SI's ready for each team and ribbons if you are using them

Have sheets of paper with numbers 1-x written out for drawing of rotations or have rotations filled out and printed

#### Skippers Meeting

Hand out rotation

Be sure to describe marks, location of official notice board and where signals will be displayed ashore.

Explain that protests will be heard on the dock in between races using the 3 minute justice system out lined in Addendum B.

Advise coaches that they may be recruited to serve on the protest committee

### After Racing

Fill out scratch sheet

Fax/email scratch sheet to regatta chair – Caleb Silsby 949-673-3972

Put all other regatta documents (Entry List, Rotation Sheet, Individual Race Scores, Protest Notes and Scratch Sheet) in envelope and deliver to regatta chair

## SAILING INSTRUCTIONS



### 1 RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing 2005-2008.
- 1.2. The class rules of the International Naples Sabot Association will be in effect except as modified by these sailing instructions.
- 1.3. The Dick Sweet Trophy Deed of Gift/Regatta Conditions as published in the 2007 SCYYRA Handbook will prevail.

### 2 ELIGIBILITY / ENTRY

- 2.1. Each SCYYRA recognized club is allowed one team. A team consists of three skippers who are all members of or regular participants in their club's junior program.
- 2.2. Eligible teams may enter the series by registering with the SCYYRA Dick Sweet Series Chair prior to June 28, 2007.
- 2.3. Approved teams must notify the host club of their intent to race by 1800 on the Thursday prior to the event.
- 2.4. Teams are required to fill out a formal registration on the morning of each event.
- 2.5. The entry fee will be \$100 per team for the 2007 series.

### 3 NOTICES TO COMPETITORS

- 3.1. Notices to Competitors will be posted on the official regatta notice board identified at the competitors meeting.

### 4 CHANGES TO THE SAILING INSTRUCTIONS

- 4.1. Any changes in the sailing instructions will be posted at least 20 minutes before the start of the first affected race.

### 5 SIGNALS MADE ASHORE

- 5.1. Signals made ashore will be displayed from the flagpole identified at the competitors meeting.
- 5.2. When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 20 minutes'

### 6 SCHEDULE

### 7 FORMAT

- 7.1. The rotation schedule will be passed out at the competitors meeting.
- 7.2. The regatta will be comprised of three rounds. The first two rounds will be complete round robins. The final round will be a "knock out series" of either 4 or 8 teams. The OA reserves the right to modify the format based on weather conditions, time constraints or other factors that the OA deems necessary.

## 8 COURSE/MARKS

- 8.1. The Course will be a "Digital N" as illustrated in Addendum A. Marks will be rounded as follows: Start - W1(s) – W2(s) – L1(p) – L2(p) – Finish.
- 8.2. The marks will be described/displayed at the competitors meeting.

## 9 START

- 9.1. The starting sequence will be according to RRS Appendix Q.
- 9.2. The starting line will be between the staff from which an orange flag is displayed on the RC signal boat at the starboard end and the course side of the port-end starting mark.
- 9.3. The start line is restricted to all boats except those that are starting.
- 9.4. Teams may engage at their respective two-minute signal.
- 9.5. A boat starting later than 4 minutes after her starting signal will be scored Did Not Start. This changes rule A4.

## 10 RECALLS

- 10.1. Each yacht's recall number shall be her sail number.
- 10.2. Recalls will be in accordance with RRS Appendix Q6

## 11 FINISH

- 11.1. The finish line will be to port of the RC finish boat.
- 11.2. The finish line is restricted to all boats except that are finishing.

## 12 PENALTY SYSTEM

- 12.1. As provided in rule 67, the protest committee may, without a hearing, penalize a boat that has broken RRS 42.
- 12.2. Any suspected use of illegal drugs or alcohol on or off the racecourse during the course of the regatta shall result in a hearing under RRS 69 Allegations of Gross Misconduct.

## 13 PROTESTS and REQUESTS FOR REDRESS

- 13.1. Protests and requests for redress will be heard according to an On-The-Water Jury System outlined in Addendum B.

## 14 SCORING

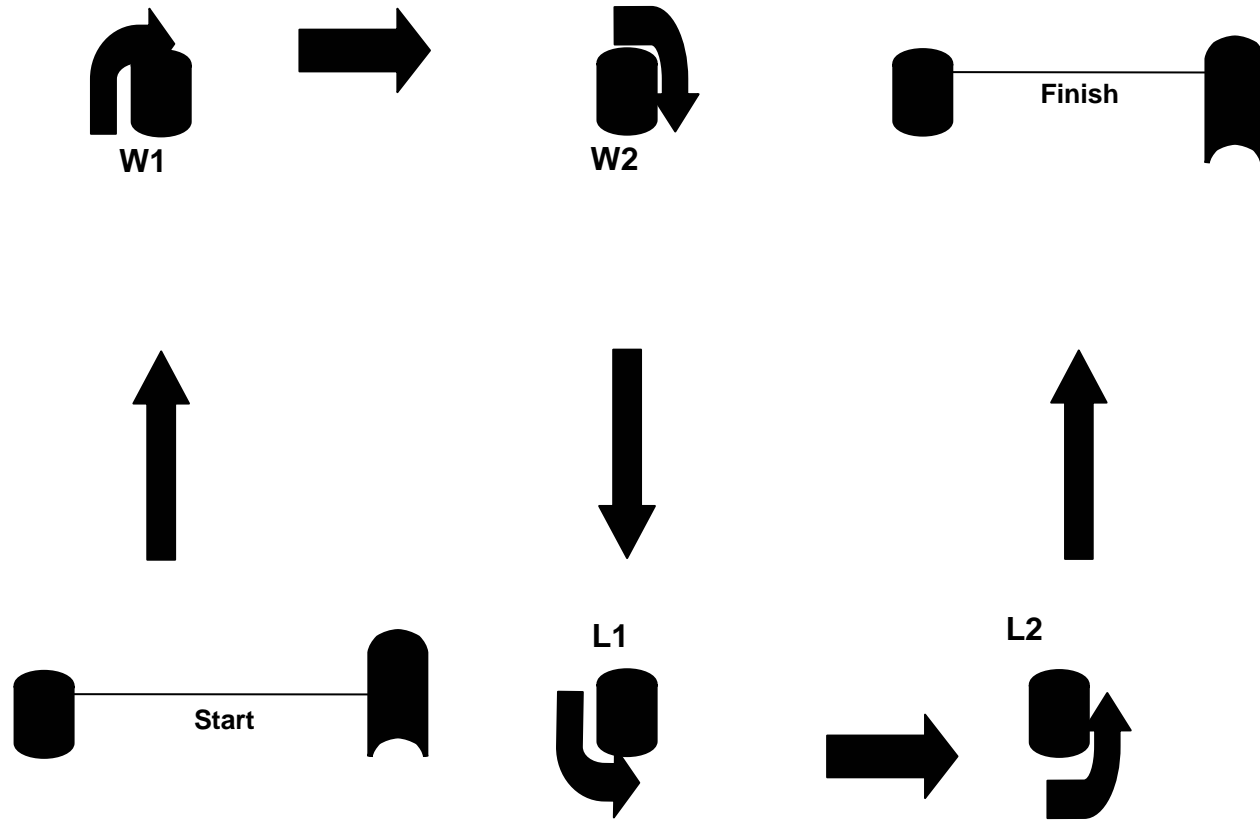
- 14.1. Individual races will be scored according to Appendix D3.
- 14.2. The regatta and the series will be scored according to Appendix D4.
- 14.3. If a tie exists in determining the winner of the regatta, a sail off shall break all ties for the series. If a sail off race cannot be started by 5:00 PM the day of the races, the tie will be broken according to rule D4.2

## 15 TROPHIES

- 15.1. The SCYYRA Dick Sweet Sabot Team Race Perpetual will be awarded to the winning club, keeper trophies will be awarded to the skippers.

On-The-Water Jury System

**Protesting and the Hearing**

- 1 Two or more boats are involved in a rules dispute during a team race and one boat (Protestor) decides to protest another boat (Protestee).
- 2 The Protestor notifies the Protestee by clearly using the word "PROTEST"
- 3 If a Protestee does not take a penalty, the Protestor has the opportunity to "file" a protest with the RC at the conclusion of that race.
  - 3.1. Filing a protest is done by verbally notifying the RC.
  - 3.2. Protestor must file the protest as soon as practicable after finishing.
- 4 The RC will notify the Protestee that a protest has been filed.
- 5 As soon as practicable, the Protest Committee will hold a "three minute justice" hearing:
  - 5.1. The Protestor and Protestee will be pulled aside by the Protest Committee. Hearings will be held on a side finger identified at the competitors meeting.
  - 5.2. Before reaching the finger dock, the Protestee can accept a penalty and get the same points as would be awarded if she lost the hearing.
  - 5.3. Before reaching the finger dock, the Protestor can either withdraw the protest without penalty or can accept a penalty and get the same points as would be awarded if he or she lost the hearing.
  - 5.4. The Protest Committee will assume that the Protestee was properly notified at the time of the incident.
  - 5.5. Once the competitors are on the Protest Committee platform and the hearing has begun, the Protestor has one minute to explain the reason for the protest.
  - 5.6. The Protestee then has one minute to explain the opposing position
  - 5.7. The Protest Committee will then dismiss the two competitors and will deliberate and reach a decision in one minute.
  - 5.8. The decision of the Protest Committee is final and cannot be appealed.

**The Decision and Penalties**

- 6 Either boat may be penalized
- 7 If a boat has broken rule 1 or 2, rule 14 when she has caused damage or injury, or rule 28.1 and as a result her team gained an advantage, the penalty will be 10 points and/or whatever other penalty the Protest Committee deems appropriate.
- 8 For any other rule broken while racing, the penalty will be 6 points.

**Notification**

- 9 The Protest Committee will notify the RC of the results of the hearing. The Protest Committee will also attempt to notify the competitors at the earliest opportunity.
- 10 It is the responsibility of the competitors to sail by the RC and ask for results of the protest hearing.

**Protest Committee**

- 11 Protest Committees will be comprised of at least two people representing different clubs and who do not have a vested interest in the decision.
