### 1. RULES:

The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS), the prescriptions of US SAILING; the rules of the C420 Class (except as any of these are altered by the Sailing Instructions); and by the Sailing Instructions.

### 3. ENTRIES AND FEES:

Each vessel shall complete all parts of the online registration process and pay all fees prior to 1000 hours on Saturday, September 15. Online registration is available via Regatta Toolbox at the following link:

Each participant (skipper and crew) must submit a completed CBYC Parental Consent Form, signed by his or her parent or guardian, no later than 1000 hours on Saturday, September 15. This shall be delivered to the check-in desk during the designated check-in time.

The entry fee is \$65.00 for this regatta. **A separate entry and fee (\$20) to SCYYRA for the Perry Series is required.**

#### **4. SCORING:**

The Low Point System of the RRS Appendix A will apply, except that if 6 or more races are completed, a boat score shall be the total of the scores excluding the worst.

Nine (9) races will be attempted. There will be one throw-out, if six (6) or more races are completed.

#### **5. ELIGIBILITY AND BOATS:**

#### **6. SAILING AREA:**

Inside the Federal breakwater, west of LA Light.

**Liability Waiver and Release Agreement**

I wish to voluntarily involve the above minor in the Cabrillo Beach Yacht Club’s regatta. In consideration of the minor's participation in this voluntary recreational activity, I acknowledge and agree as follows:

1. To the fullest extent permitted by law, I promise not to sue, I forever release and hold harmless CBYC from and against any and all claims, damages, liabilities, losses, costs and expenses including attorney fees, for personal injury to the minor or any other person and/or loss of any property, arising from the minor's participation in the sailing program and shore side activities and any active or passive negligence of CBYC, such as negligent rescue.
2. I represent that the minor is in good health, is able to undertake sailing activities, and can swim well enough in the event his/her boat capsizes to avoid any resulting danger. I further represent that the minor is capable of comprehending instruction, following directions and observing proper safety precautions. I agree to abide by the decisions of the CBYC Officer if he/she finds it necessary to discipline or dismiss the minor for lack of attention misbehavior or failure to follow safety precautions.
3. For the purpose of the Agreement, CBYC shall include its directors, officers, employees, agents, and committee persons of any of them. If any term of this Agreement is held invalid, the remaining terms shall continue in full force and effect. This Agreement shall survive the termination of the minor’s participation in CBYC’s regatta.

I am aware that this is a broad release of liabilities agreement and I sign of my own free will without any inducement or assurance of any kind.
