1. HOST CLUBS AND DATES

2. ELIGIBILITY, ENTRY, ENTRY FEE

2.1. A skipper cannot count a regatta in the series scoring or enter a new series if he or she is 19 years of age or older or has attended college prior to entering the series or participating in a particular Regatta.

2.2. Entries for the 2024-2025 Ullman/Frost Series and each separate Ullman/Frost Series Regattas must be filed online using TheClubspot.com. You need to complete an entry for each Ullman/Frost Series Regatta and a separate entry (one time - free) for the 2024-25 Ullman/Frost Series itself. A \$10 Series Sanction Fee from each regatta will go to SCYYRA (This is the Series Entry Fee). If you compete in the first 2 of the 4 regattas in the series, you will get a t-shirt (or similar participation item). Using TheClubspot.com please make sure that you are entered in both the SCYYRA Ullman/Frost Series AND all regattas that you will compete in.

2.3. Entries will only be processed online using TheClubspot.com and can be accessed via the Ullman/Frost Series links at www.scyyra.org

2.4. All boats must be class legal according to the International Laser Class Association North American Region.

3. CLASS MEMBERSHIP

3.1. All skippers shall be a member in good standing of the International Laser Class Association North American Region.

3.2. Membership can be obtained on the ILCA North America website at <https://ilcanasailing.org/> - click on "Join". Junior class membership (under 18 years old) is approximately \$45. Please include your ILCA membership number when completing your online entry. Class membership information will be verified.

4. RULES

4.1. Each regatta will be governed by the RRS, the prescriptions of US SAILING, Ullman/Frost Series Rules as published on the SCYYRA website, ILCA Class rules, this Notice of Race and the Sailing Instructions issued by each host club.

5. SCORING

5.1. The Low-Point Scoring System, rule A2, will apply with 20 or more races scheduled. A DNC will be based on the total number of entries in the series. A DNF, DSQ and DNS will be based on the total number of Ullman/Frost Series starters in each individual regatta.

5.2. Throwout races will be incorporated into the series scoring with the following formulas: • If 14-15 races are completed, there will be 1 throwout

- If 16-17 races are completed, there will be 2 throwouts
- If 18-19 races are completed, there will be 3 throwouts
- If 20 or more races are completed, there will be 4 throwouts

5.3. Sail number and crew changes must be approved by the Ullman/Frost Series Chairman, Nick Kaschak and reported to the race committee before the first race each day.

5.4. **Races sailed on Fridays of three-day events will not be incorporated into the series scoring.**
